THE PURPOSE & VISION OF DECODE

The DECODE Knowledge Project aims to enhance the role of locally grounded, contextualised and actionable knowledge in addressing community-identified challenges. The project led by the UNESCO Chair in Community-Based Research and Social Responsibility in Higher Education engages global networks of community and Indigenous-led research practitioners through peer learning, collective reflection, and systematisation.

Guided by a gender-sensitive and decolonial lens, the initiative builds on the foundational concepts of knowledge democracy and community knowledge cultures developed by the Co-Chairs Dr. Rajesh Tandon and Dr. Budd Hall.

It aims to systematize existing practices in participatory research to draw lessons on values, ethics, and methodologies that contribute to multidimensional impacts on today's development challenges. Through peer learning and collective reflection, the project fosters knowledge exchange among global networks of civil society actors, academics, and community research practitioners to deepen understanding of the principles, policy implications, and enabling infrastructures necessary to advance community and Indigenous knowledge movements.



Central to this initiative is the development of an open-access digital platform for CBPR knowledge, developed by PRIA (India) and the University of Victoria (Canada)- offering tools, resources, and insights to support and strengthen inclusive research infrastructures worldwide. This will be an evolving space to share DECODE's outcomes alongside other community-driven and Indigenous-led research efforts, advancing the global movement toward knowledge democracy.
